

## **END-USER LICENSE AGREEMENT FOR WEBROTATE 360 PRODUCT VIEWER**

This WebRotate 360 Product Viewer End-User License Agreement ("EULA") is a legal agreement between you and WebRotate 360 LLC for the WebRotate 360 Product Viewer software identified above, which product includes computer software and may include associated media, printed materials, and "online" or electronic documentation ("Software Product" or "Software" or "Product"). By installing, copying, or otherwise using the Software, you agree to be bound by the terms of this EULA. WebRotate 360 Product Viewer is licensed, not sold.

**Do not use this Software until you have carefully read the following terms and conditions. By using the Software, you agree to the terms of this Agreement. If you do not agree to the terms of this Agreement, do not install or use this Software Product.**

### **GRANT OF LICENSE**

This EULA grants you the following rights: Use and Copy. WebRotate 360 LLC grants to you the right to use copies of the Software only in conjunction with a validly licensed copy of WebRotate 360 Product Viewer. You can resell services derived from the use of your license however, you may not resell product licenses.

**Free license:** if this Agreement is included with the Free edition of the Software, you are granted a limited non-exclusive license to use copies of the enclosed Software on any number of computers, web sites and for any number of product presentations created by the Software. You must maintain all copyright notices on all copies of the Software, including all hyperlinks accessible within the running Product.

**Professional license (labeled as PRO):** if this Agreement is included with the Professional edition of the Software, you are granted a limited non-exclusive license to use copies of the enclosed Software on any number of computers, web sites and for any number of product presentations created by the Software. You must maintain all copyright notices on all copies of the Software.

**Enterprise license:** if this Agreement is included with the Enterprise edition of the Software, you are granted a limited non-exclusive license to use the Software for any number of product presentations accessible under 3 web domain names. In other words you need one Enterprise license for every three websites using this software. Each purchase provides you with a Single-User license. You need one license for each developer using the product in your organization, including temporary or freelance developers.

### **RESTRICTIONS**

- You may not reverse engineer, decompile, or disassemble the Software, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.
- You may not resell, rent, or lease the Software.
